

NORTH HEIDELBERG TOWNSHIP, BERKS COUNTY, PENNSYLVANIA**RESOLUTION NO. 2016-02****A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE TOWNSHIP OF NORTH HEIDELBERG, BERKS COUNTY, PENNSYLVANIA, ADOPTING AN OPEN RECORDS POLICY FOR NORTH HEIDELBERG TOWNSHIP**

WHEREAS, the Pennsylvania Second Class Township Code, Article VI, Section 1506, charges supervisors with the governance of the township necessary for the proper maintenance, care and control of the township and the maintenance of peace, good government, health and welfare of the township and its citizens, trade, commerce and manufacturers; and

WHEREAS, the Pennsylvania Right To Know Law, 65 P.S. Section 504(b), provides for the posting of the regulations, policies and procedures in each township beginning January 1, 2009; and

WHEREAS, it is essential to the proper operation of the government of North Heidelberg Township, as well as to assure that the laws are faithfully enforced, that an Open Records Policy be adopted; and

NOW, THEREFORE, BE IT RESOLVED, that the attached Open Records Policy be adopted for the Township of North Heidelberg.

FURTHER RESOLVED, that the attached policy shall take effect at 12:01 p.m. prevailing time on January 1, 2009, or as soon as legally permissible thereafter.



FURTHER RESOLVED, that all Resolutions or parts of Resolutions inconsistent with this Resolution are hereby superseded.


